

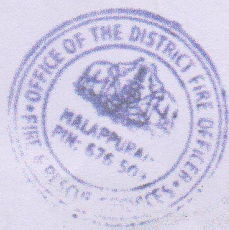

## NO OBJECTION CERTIFICATE


### (RENEWAL)


2. In the circumstances this no objection certificate is issued under my seal and authority for the contained occupation of the above building. No further construction will be allowed in the vacant spaces provided in approved plan.

3. This certificate is issued on the condition that the fire fighting systems installed will be kept always functional and the owner of the building should take special care to maintain the systems installed in proper working condition. This certificate is valid for one year from the date of issue. After one year the certificate must be renewed. Non renewal of the certificate within the time limit will result in loss of eligibility for insurance coverage and appropriate legal action by the local self Government/Revenue Department. All officers of and above the rank of Station Officers of Fire and Rescue Service Department will have the right to inspect the building on any day/time after serving 7 days notice to ensure that installed system are in good working condition.
